#### You Need To Provide:



#### **Passport**

The traveller's actual passport. The passport must:

- Be valid for six months beyond the applied visa period
- Have at least two blank facing visa pages
- Be submitted without passport cover (please remove any cover before submitting the passport to VisumCentrale)



#### Photograph(s)

You must provide a photograph. Upload your photo and we will print it to the exact specifications required for this visa. Follow <a href="http://visumcentrale.de/photo-service.php">http://visumcentrale.de/photo-service.php</a> to upload your photo.

Alternatively, you may provide one colour, passport type photograph that meets the following strict criteria: be taken within the last three months against a white background and printed on high quality photo paper; be 35mm by 45mm in size; provide the full frontal view of your head with your face centered in the middle and displaying a neutral (non-smiling) expression. You may wear no headwear except for religious purposes. Your photograph should not be affixed to your application and may not display evidence of adhesive or staples.



#### Tourist Reference

A Tourist Reference. The letter must:

- Be obtained by the tour operator or hotel in Russia
- List all places to be visited

VisumCentrale can obtain a Tourist Reference on your behalf. Simply complete the Russia Tourist Reference Order Form provided in the application pack and send it to us together with the other application papers.



#### **Income Statement**

Evidence of sufficient funds (at least €1,000) must be provided, in the form of one of the following (copies are acceptable):

- An employer's confirmation of employment, stating the position of the employee and indicating the monthly gross salary (the latter is not required if already provided in the business introduction letter)
- A pension statement for the last three months
- A current account statement
- Proof of residential property ownership

Self-employed applicants must submit copies of their business registration certificate and a current account statement.





#### Proof of Travel Insurance

The current typewritten insurance policy or a current typewritten certificate of insurance which must:

- Certify its validity for the entire duration of the visa
- State the applicant's full name
- Contain the insurance company's contact data
- State the insurance policy number
- Guarantee return transport in the event of death
- State a minimum cover amount of €30,000.00
- Certify that the insurance cover is valid for the Russian Federation
- Be signed by the insurance company
- Be provably dated within the last three months

If any of these details is not shown in the confirmation, please contact your insurance company in order to request a corresponding letter.

#### Visa Application Form

The fully completed online application form available at <a href="https://visa.kdmid.ru/">https://visa.kdmid.ru/</a> must:

- Not have handwritten corrections or amendments
- Contain the words "nicht zutreffend" in all fields that are not applicable
- State the date of application in the appropriate field
- Bear a signature which matches the one in the passport
- List all places to be visited
- Not contain incorrect or incomplete information (consulate charges 5,00€ for corrections)

Important: Under "Place of Application", the relevant Visa Application Center must be given. Applications in which the Russian Consulate is stated under Place of Application are not accepted.

Alternatively VisumCentrale can assist the traveller in completing the online application form as a Premium Service at a cost of  $\in$ 32.01 incl. VAT ( $\in$ 26.90 plus VAT), plus all other consular and VisumCentrale service fees.In order to facilitate this, please complete the VisumCentrale Russia Form Fill Request which can be found within the VisumCentrale Application Pack.

Online application form fill requests must be received, together with all application documents, at VisumCentrale before 14.00 hours in order to have it returned to you that day. Once VisumCentrale have completed your online application we will send it to you for your signature. An original signature is required so it is mandatory to return the form to us by post or courier once signed.



#### VisumCentrale Order Confirmation

For orders placed on the VisumCentrale website, a copy of the Online Order Confirmation which is sent to you via email, must be submitted.

For all other orders, and where applicable, a completed VisumCentrale Order Form which can be found in the VisumCentrale Application Pack should be submitted.

#### Minors Under 18 Years of Age

Minors must provide copies of their birth certificate and proof of a parent's income for the last three months.





#### **Double Entry Applicants**

A double entry visa will only be granted if the indicated travel route necessitates this.



#### Holders of an Existing Valid Visa

On application for a new visa, any previously valid Russian visas in the submitted passport will be cancelled. This cancellation may also affect valid visas in other passports of the applicant.



#### Former Russian or Soviet Citizens

Former Russian or Soviet citizens are required to:

- State reasons for and the date when they renounced their former citizenship
- Enclose a copy of the expatriation document


